- 1) Board Members Present: Supervisor, Arlan B. Meekhof; Clerk, Beverly Jaarsma; Treasurer, Randy Vander Zwaag; Trustees, Todd Wolters and Terry Hossink.
- 2) Meekhof called the meeting to order and Wolters offered prayer.
- 3) Approved minutes of Regular Meeting of January 19th and Joint Special Meeting of February 8<sup>th</sup>.
- 4) Treasurers report: Transfer of \$52,000; Checking/Balance \$4, 413.08.
- 5) Adopted Ordinance 2006-02-01 to repeal Article 9, HDR High Density Residential District and to amend Sections 3.03, 5.02aA, 18.11B, and 19.03 A1.
- 6) Approved a Special Use Permit for Merryman Dog Kennel's.
- 7) Approved a Sand Mine Permit renewal for Turkey City Sand Mine.
- 8) Approved a Special Use Permit renewal for Dennis Aukema for Storage in AG.
- 9) Approved to table the proposed Disorderly Conduct Ordinance, for review.
- 10) Approved to amend our fee schedule to read ~ "letter of Credit" where applicable.
- 11) Fire Committee Report: a) TB Testing done b) Fitness test in March c) Medical testing coming.
- 12) Approved the Fire Budget of \$229,000 for the 2006-2007 Budget.
- 13) Approved to contract with I.T. Right to back up township data daily at a cost of \$500 annually, and to use the services of Daniel Eggleston for troubleshooting.
- 14) Approved to hold the annual Township Clean up on Saturday, April 29<sup>th</sup> at the "Old" Township Hall at 11768 Polk Street. Watch for April newsletter for "Disposal Coupon".
- 15) Lawn Care bids are now being accepted for the Olive Township Hall complex at 136<sup>th</sup> Avenue and the Center Station near Borculo. Written bids, with proof of Insurance, are to be submitted to Arlan B. Meekhof by March 16<sup>th</sup>.
- 16) Approved the reappointment of Lucile Van Koevering, for a 2-year term, to the Board of Review, Ron Nienhuis, for a three-year term, to the Board of Appeals and Garry Dreyer, for a 3-year term, to the Planning Commission.
- 17) Board of Review will hold sessions March 13, 14, and 15<sup>th</sup>.
- 18) Approved to support the Preliminary Design Option with Holland Engineering at a cost not to exceed \$120,000 for a sewer study along Port Sheldon from 136<sup>th</sup> Ave. the Borculo area.
- 19) Approved the 2006-2007 Budget to be presented at the Annual Meeting to be held Thursday, March 16<sup>th</sup> at 7:00 p.m.
